- 1. January Meeting Minutes Approved
- 2. President's Report (M. Boschi):
  - a. Summary of League Meeting hosted by Cory: Things are not well with NHSA.
    Purpose of meeting was to drum up support to get people involved with the board. Next Tuesday is an NHSA Meeting and M. Boschi will attend this one as well- hopefully determination of the new director will be discussed in this forum.
  - **b.** Black Out Dates: Due February 4<sup>th</sup> (keep in mind that we do play over April vacation).
  - **c. Pavilion:** M. Boschi is gathering information and pricing with a contractor to have pavilion built at Sawmills.
- 3. Treasurer's Report (M. Duprey): No new expenses, nothing new.
- 4. Equipment Coordinator Update (T. DeCarli):
  - a. **Nets:** They came in and J. Jozokos we already used them. Easy to set up and take down.
  - b. Balls: Terri ordered some size 4 and 5 balls with left over credit at Soccer.com
  - c. **Uniforms:** We need to figure out teams so that Terri can order high school uniform. Chuck will send her the list and Terri will order them through a separate company (not soccer.com).

- 5. **Field Coordinator Update** (J. Craig):

      - 3. Email to all parents to request help
