- 2. President's Report (J. Bourque):
  - **a. Training:** Jenn is waiting to hear back from Bruno on further details about training but we are looking to do 2 nights with 3 slots per night.
  - **b. Pictures:** We are aiming to do a picture day with Tricia and fit all teams on one day.
- 3. Treasurer's Report (C. Izbicki): nothing to report
  - i. Non-Profit: G. Barillas will look into finding someone in helping us with figuring out how to get non-profit status.
- 4. Equipment Coordinator Update (T. DeCarli):
  - a. Scholarships: all updated and will get everything to the school
- 5. Field Coordinator Update (B. Bourque):
  - a. Fields:
    - i. We will utilize all 3 fields for this spring especially because LAX will be looking to use Sawmill for practices as well.
- 6. **Travel Report** (C. Asara):
  - a. Final Prices for High School Teams: \$95.00 (we decided this last week.)
  - **b. Total Registered:** ~28 registered (all boys).
    - i. **M. Boschi:** Did send email out to the boys and gave range \$85 to \$110.00.

- **c. Second Coach Needed:** Do not have this yet for high school.
- d. Should we have teams with roster space adding players via a tryout?
  - We usually handle by a case-by-case basis but the younger teams have some spots available so we could host a tryout at Sportsplex
    - a. Motion: Chris is making a motion to do another tryout for select teams that need players (M. Boschi, 2<sup>nd</sup>),
    - i. Motion Passes: 8 yes and 2 no, 1 abstained.
      - (We are treating this as a one-off because of COVID)
      - ii. Chris will take the lead to find date and communication plan (need to do soon because team registration is March 31st)
      - iii. Price: We should charge ½ price

\*\*\*Agenda item: Discuss in March, do we want to allow one season teams? Idea floated (M. Fluet): we should set a minimum roster number so at mid-year, there is already criteria set to determine whether additional players are needed or not.

- e. In State Tourneys again this Spring: It is likely that we will need to stay in state but we can table this discussion to later date.
